Balance Sheet

- Assets: 31-12-2014: 89'305.15 (31-12-2013: 96'848.85)
 - This includes transitory liabilities of 25'830.- (membership fees 2015 paid in 2014) and transitory assets of 9'760.34 (SCNAT support of SWAPS paid in early 2015)
 - Net assets on 31-12-2014: 63'475.15 (31-12-2013: 69'818.85)
- Decrease in assets 2014: CHF <u>-6'343.70</u> (2013: +8'756.15)

Auditor's report (distributed)

- The audit took place on 29 Jan. 2015 in Bern with two auditors Giuseppe Iacobucci & Michael Spira – Marc Türler (CHIPP administrator), and Ms. Monika Röllin (accountant, UZH).
- According to the auditors, the statements fairly represent the financial position of CHIPP, have been prepared with care and comply with statutory requirements.
