

## Agenda item 10: Next RECFA country visit to Switzerland (1)

- The Restricted European Committee for Future Accelerators (RECFA) visits each of its represented country about every seven years and this is now due for Switzerland in 2016.
- The meeting is held on a Friday followed by dinner and a closed session on Saturday morning including lunch.
- It is not limited to accelerators, but is rather a review of all CHIPP-related activities, including astroparticle and neutrino physics, nuclear physics related to CERN and outreach.
- RECFA then formulates recommendations which can be conveyed to the Swiss funding agencies.
- Meals and accommodation shall be organized for ~25 members of RECFA.




### Agenda item 13: News from the Round Table International (1)

- The last Round Table International (RTI) meeting took place on 14 April 2015. The following points are of interest:
  - **CHIPP**: Presentation of the three pillars of CHIPP, with financial needs for the LHC experiments, and news on neutrinos.
  - Future Circular Collider (FCC): Lenny Rivkin was invited to present this project. Its importance for the long-term future of CERN was recognized. All Swiss institutes active in the LHC are invited to be(come) part of the collaboration (contact Lenny). A letter is to be sent to Mauro Dell'Ambrogio signed by H.R. Ott (MAP Platform of SCNAT), Rivkin, and Schneider. It has now been sent.
  - FLARE: Less astronomy requests as expected for 2015 leaving a bit more money for 2016 (7.7 MCHF). Continuation expected in 2017–2020 with slightly increased funding.

## Agenda item 13: News from the Round Table International (2)

- Roadmap of Research Infrastructures: The process is on-going at the SERI aiming at a first version this summer for the Federal Council. [On June 24, such document appeared on the SERI web site, mentioning 38.4 MCHF for the FLARE 2017-2020 budget.]
- HL-LHC in ESFRI: Eligibility of HL-LHC in ESFRI is being debated, because it can be seen as an incremental update of LHC and not as a new project. Funding decision to come from member countries based on a recommendation of the Science Working Group.
- CTA: Decision on the Southern and Northern sites expected in the coming 6–9 months.
- **Astronomy**: The update of the Swiss Roadmap of Astronomy was then in the printing process and has now been distributed.

## Agenda item 14: SCNAT funding requests

- The SCNAT funding request of the MAP platform is due by 28 August 2015 to cover expenses in 2016.
- CHIPP will ask support for:
  - SWHEPPS 2016: Strategic Workshop on High-Energy Particle Physics in Switzerland, see below (10'000 CHF)
  - The PSI Zuoz Summer School, 7–13 August 2016 (10'000 CHF)
  - A continuation of the "Dialogue" Outreach project, to keep some activity in "particlephysics.ch" with limited means due to the end of the SNSF-Agora funding (~5000 CHF?)

### Agenda item 15: Swiss EPPCN member

- We reported last year (Board 2014-02) on the steps done towards finding a successor to Beat Gerber (ETHZ) who acted

   until retirement in March 2014 – as the Swiss member of the European Particle Physics Communication Network (EPPCN).
- The issue is still not settled, but the following evolutions can be reported:
  - The end of the SNSF-Agora project "Interactions", means that Benedikt Vogel is not willing to become EPPCN member.
  - As scientific delegate to the CERN Council, I wrote a letter to Martin Steinacher (SERI) to ask for financial support for this task.
  - Hans Peter Beck took contact with a few Swiss scientific journalists to probe their interest and discuss conditions.



### Agenda item 16: SWHEPPS 2016: Strategy Workshop on High-Energy Particle Physics in Switzerland

- After the successful strategy workshop on astro-particle and neutrino physics (SWAPS 2014), the EB proposed to have a similar 3-day workshop on High-Energy Particle Physics in 2016 on:
  - Higgs Boson
  - Standard Model (SM)
  - Beyond SM and Dark Matter
  - Flavour Physics
  - New accelerators & detectors
- · Theory developments
- · Connection to other fields:
  - astroparticles
  - neutrinos
  - low energy precision frontier
- The scientific organising committee has been completed as:
  - Iacobucci (ATLAS), Wallny (CMS), Nakada (LHCb) and Colangelo (Theory)
- A small group of local organisers shall also be set up.
- The preferred date is: Wed. 8 June to Fri. 10 June 2016
- Still possible places are: Seminarhotel am Aegerisee (offer received), Hotel Seedamm in Pfäffikon, and Hotel Arte in Olten.


